1. When is the Walk?

Thursday 30 September 2010; team registration takes place from 4.30pm – 6.00pm.

2. Where does the Walk start?

The Walk starts at the Combined Courthouse, Oxford Row, where all teams can sign in and collect their maps. It then follows a 10km route around Leeds.

3. Who can take part in the Walk?

The walk is open to all members of the local legal community and not for profit sector as well as family and friends – the more the merrier!

4. How many members can be in a team?

There is no limit on the number of members in a team, although we do ask that all team members (except children) collect sponsorship.

5. Who is the Walk raising money for?

The Walk is raising money for hard pressed legal advice and support charities in the area covered by the North East circuit, from South Yorkshire to Northumberland. These agencies help to facilitate access to justice for the poorest and most disadvantaged members of society, providing free legal help to people facing problems such as homelessness, debt, employment and family issues. During these difficult financial times the need for funds to support this vital work is even greater than usual.

Sponsorship monies are being collected by the North East Legal Support Trust, registered charity no. 1101906. The Trust will distribute 100% of funds raised to legal charities and has recently distributed £8328 to eight agencies in the region.
